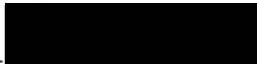



Standard Agreement #29-13FT, dated January 16, 2013, between the District and Costa Mesa Police Department is hereby amended as follows:

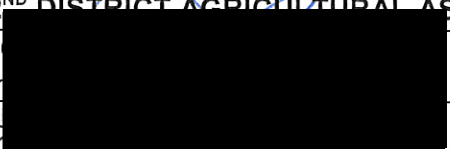
