AMENDMENT NUMBER ONE TO PROFESSIONAL SERVICES AGREEMENT FOR MEDICAL REVIEW

This Amendment is made and entered into this 1st day of December, 2013 ("Effective Date") by and between the CITY OF COSTA MESA, a municipal corporation ("City") and OCCU-MED, LTD, a California Corporation ("Consultant").

WHEREAS, Consultant and City entered into an agreement dated August 31, 2012, for Consultant to provide services relating to coordinating and reviewing medical pre-employment placement exams with candidates and the designated medical facility, making hiring recommendations to the City and review invoices and directly billing the medical facility (the "Agreement") which will expire on November 30, 2013; and

WHEREAS, the Parties understand that City will issue a Request For Proposals ("RFP") for the services provided under the Agreement which is anticipated to complete on or about March 30, 2014; and

WHEREAS, Consultant and City desire to extend the term of the Agreement so that the services thereunder continue uninterrupted until the RFP process completes on or about March 30, 2014.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

- 1. The term of the Agreement set forth in Section 4.1 of the Agreement shall be extended through March 30, 2014.
- 2. The compensation set forth in Section 2.1 of the Agreement shall be increased by an amount not to exceed Twelve Thousand Five Hundred Dollars (\$12,500) for the services rendered during the extended term.
- 3. All terms not herein defined shall have the same meaning and use as set forth in the Agreement.
- 4. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment and previous Amendments, shall remain in full force and effect.
