#### **MINUTES**

President Lea Lowe called the meeting to order at 6:18 PM. Present was: President Lea Lowe, Treasurer Mary Fewel, and Secretary Karen Ursini. - I. Public Comment: There was none.
- II. Minutes: The minutes from the March 4<sup>th</sup> regular meeting should be corrected to state that "a line item for General Marketing will be added to the 2014 budget." Also an "a" should be added between "is" and "fund" in the third sentence under Treasurer's report. ### **VI.** COMMITTEE REPORTS:

- Concerts: Mary reported that as of now, we have committed \$22,000!
  Some of the sponsors are the Orange County Fair Board, the Sanitary
  District, the Costa Mesa Water District and the Conference and Visitor
  Bureau. Pete suggested we contact the senior apartment complex named
  Azulon. She reported that there will be a 12 page program this year
  covering all of the concerts. She also encouraged us to think of possible
  sponsors and give her the names and contact information.
- Grants: Karen told of a request we received from the Costa Mesa Chamber of Commerce to again participate in the scholarship award breakfast for Costa Mesa High schools and Orange Coast College. For a number of years we have granted them \$1,000 for the scholars. Mary moved that we again grant them \$1,000. Dean seconded it and it passed. Karen will get information about the time and place of the breakfast and see if anyone could attend with her. Pete suggested we think of giving our own award.
