The Bikeway and Walkability Committee (BWC) of the City of Costa Mesa, California met in a special meeting session at 6:30 p.m. on Wednesday, September 16, 2015.

1. CALL TO ORDER

3. PRESENTATIONS – PROTECTED BIKE LANES POWERPOINT PRESENTATION BY VICE-CHAIR CYNTHIA MCDONALD

Vice-chair Cynthia McDonald made a presentation on the various types of protected bike lanes found in nearby cities. She highlighted the advantages and disadvantages of each type of bike lane, including the Joann Bike Trail in Costa Mesa.

Committee members and audience were given a copy of the presentation.

4. PUBLIC COMMENTS

- 1. Geoff West thanked the committee for all their work.
- 2. Joe Zavala of Capital Street applauded everyone for the work they are doing. He mentioned that during his morning walks he has noticed that most of the bicyclists use the sidewalk, ride side by side, and often conflict with pedestrians. He is concerned with adult bicyclists not using bike lanes.
- 3. Bob Graham is concerned with "no culture" left in bicycling by bicyclists not warning as they approach someone. He would like to post signs and educate the public on courteousness and safety.
- **4.** Teresa Drain mentioned vacated property on 19th Street. She shared an observation of the location where she witnessed pedestrians, mothers with baby carriages, and bicyclists sharing a very narrow sidewalk. She highly encouraged the committee to keep track of what happens at the City Council meetings and utilize that land, to provide better uses, that is otherwise given away.
- 5. Karl Ahlf spoke to the City Council regarding installing bicycle lockers. He mentioned people would like to make sure their bicycles are safe, especially those who spend a lot of money on their bikes.
- 6. Robin Vettraino, Executive Director of Newport Banning Ranch Land Trust, introduced herself and looks forward to working with the City and the City of Newport Beach to develop trails that connect with the beach and the Santa Ana River Trail.

5. APPROVAL OF MINUTES

Member Jim Kerins made a motion to discuss the minutes of July 8, 2015 and August 12, 2015, second by Andrea Marr. Chairman Ralph Taboada opened the item for discussion. The committee recommended a few changes to be made to the minutes. Chair Ralph Taboada called for a vote to approve the corrected minutes, motion passes unanimously.

Motion passed unanimously.

b. Review of Goals/Objectives/Policies/Programs for the Bicycle and Pedestrian Master Plan –Committee Discussion.

Member Andrea Marr moved to accept goal number one, *Promote a Friendly Goals/Objectives/Policies/Programs for the Bicycle and Pedestrian Master Plan Active Transportation System*". Member John C. Merrill seconded the motion. After discussion by the committee, the motion passed unanimously.

Member Tony Capitelli motioned to include as goal number two, *A Safe Place to Walk and Ride a Bicycle*, and add two additional goals submitted by Member Leah Ersoylu as goals three and four - *Integrate Active Transportation Elements in the Circulation System*, and *Improve Awareness and Promote Education of Active Transportation Programs*. Member Jim Kerins seconded the motion. After discussion by the committee, the motion passed unanimously.

Member Andrea Marr moved to accept proposed goal, *Promote Active Transportation Culture* as new goal number five. Member Tony Capitelli seconded the motion. After discussion by the committee, the motion passed unanimously.

City Council Liaison Katrina Foley asked the committee to consider adding a new sixth goal on economics. Member Tony Capitelli moved to add an economics goal as the sixth goal. Member Andrea Marr seconded the motion. After discussion by the committee, the motion passed unanimously.
