- Limit the number of permits to three (3) per eligible household. Additional permits will be considered based on the documented need. The permits shall be "hanger" type and interchangeable among vehicles.
- Limit the number of guest permits to one hundred (100) per eligible household per year. Residents may request an additional twenty five (25) guest permits for specific events at their residence.
- Eligible households are defined as those on a designated permit parking street and single-family households located within 250 feet of the permit parking street.

- Establish parking zones to limit parking accessibility of a permit holder within their parking zone. Permits will be color coded or uniquely marked to identify the parking zone.
- The permits in each zone will need to be renewed every three (3) years.
