# MINUTES OF THE REGULAR MEETING OF THE BIKEWAY AND WALKABILITY COMMITTEE

#### 2. PUBLIC COMMENTS

 Residents Clay Epperson, Jim Garmin, Linda Stenis, Matt Stenis, John Fletcher, Ralph Odenwald, along with several other residents of the tracts located north and south of Adams Avenue, east of the Santa Ana River Trail spoke in strong opposition to the opening of the Greenville Banning Channel access road adjacent to their homes.

# b. Arlington Bioswale Project - Presentation by Raja Sethuraman

Raja Sethuraman, Transportation Services Manager updated the committee on the Arlington Bioswale Project. He answered the committee's questions regarding the project details.

# c. Master Plan of Bicycle Facilities - Update

Transportation Services Manager presented the committee with an updated Master Plan of Bicycle Facilities. After discussion by the committee, Member John C. Merrill moved to file the map as conceptual and seek funding for CEQA (California Environmental Quality Act) review, Vice-Chair Cynthia McDonald seconded the motion. The motion passed unanimously.

# d. Pedestrian Opportunity Zones - Discussion

Raja Sethuraman presented the Pedestrian Opportunity Zones included in the General Plan Update to the Committee. There was discussion regarding expansion of these pedestrian zones to other areas of the City, particularly along Fairview Road adjacent to Orange Coast College.
