NOTICE IS HEREBY GIVEN that on Tuesday, July 5, 2016, the City Council introduced proposed Ordinance No. 16-04:

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COSTA MESA TO AMEND TITLE 13, CHAPTER VIII, SIGNS, OF THE COSTA MESA MUNICIPAL CODE RELATED TO TEMPORARY PORTABLE SIGNS.

Ordinance No. 16-04 introduces an Ordinance that would consider adoption of Code Amendment CO-16-01 to amend Title 13 (Zoning Code), Chapter VIII, Signs, of the Costa Mesa Municipal Code. The Code amendment involves amending regulations applicable to temporary portable signs which are not permanently affixed to the ground or a structure(s). The scope of the proposed changes is limited to the physical regulation of temporary portable signs. Environmental Determination: Exempt.

A certified copy of the full text of Ordinance No. 16-04 is posted and may be read in the City Clerk's Office, 77 Fair Drive, Costa Mesa. The City Council will consider adoption of the proposed ordinance at the regular meeting on **August 2, 2016 at 5:45 p.m.**
