Discussion ensued on whether applicant would consider paying for removal of the tree.

2. Scott Waterman, Costa Mesa, applicant of tree removal request, spoke on current and potential damage.

Discussion ensued on cost of tree removal by applicant.

3. George Berg, Costa Mesa, welcomed Commissioner Mercurio on her appointment, spoke on a root barrier for the tree and the lack of notification to neighbors.

Discussion ensued on notifications for tree removal requests, government request vs. homeowner request, precautionary measures and the continued eventual damage, planting of a replacement tree, and plants that could be grown along the private property/barrier wall.

MOTION made by Commissioner de Arakal to approve tree removal under Category 2 accelerated removal with the cost of the tree removal to be borne by the applicant, seconded by Commissioner Pederson. MOTION carries 4-0.

b) Proposed Landscape Palette for Fire Station No. 1

Presentation by Mr. Arash Rahimian and WLC Architects.

Discussion ensued on landscape trees scheduled to remain, drip irrigation, good use of boulders, sightline and safety leaving the fire station, the process of reviewing tree removals as part of construction projects on previously approved Council projects, and lack of aesthetic appeal.

MOTION made by Commissioner de Arakal to approve the removal of 16 trees growing on-site at Fire Station No. 1 located at 2803 Royal Palm Drive and approve planting plan and palette for the proposed landscape improvements at Fire Station No. 1., seconded by Commissioner Mercurio. MOTION carries 3-1.

Discussion ensued on feasibility of security cameras for Skate Park expansion, Open Space Master Plan Workshop, and construction at Smallwood Park.
