- a) CHANDLER ASSET MANAGEMENT QUARTERLY REPORT Jayson Schmitt from Chandler Asset Management presented the quarterly report. It was a volatile quarter due to the European Brexit issue and he predicts the Feds may raise rates by the end of the year.
