**NOTICE IS HEREBY GIVEN** that a public hearing will be held by the Costa Mesa City Council at the Special meeting on **Monday, October 17, 2016**, **at 7:00 p.m**., or soon thereafter as the matter shall be heard, in the City Hall Council Chambers, 77 Fair Dr., to consider the following item:

**Description:** The proposed project involves:

- 1. Adoption of an Initial Study/Negative Declaration;
- 2. **General Plan Amendment GP-16-05**. General Plan Amendment to change the land use designation of a 2.07-acre site from GC (General Commercial) to LDR (Low Density Residential); and
- 3. **Rezone R-16-05.** Rezone of a 2.07-acre site from C1 (Local Business District) to R-1 (Single Family Residential District eight (8) dwelling units per acre maximum density allowed). The General Plan Amendment and Rezone is to accommodate an 11-unit, two-story, single family residential development which will be submitted to the City for a separate public hearing at a future date.

The site address is 2850 Mesa Verde Drive East. The Applicant is Pinnacle Residential and Application Nos. GP-16-05 and R-16-05. Existing Zone: C1 (Local Business District). Proposed Zone: R1 (Single Family Residential).

**Environmental Determination:** An Initial Study/Negative Declaration (IS/ND) was prepared in accordance with the Lead Agency's Guidelines implementing the California Environmental Quality Act. The IS/ND found that the environmental effects from the project would be less than significant with the incorporation of standard conditions of approval and compliance with Code requirements. The IS/ND was made available for review and comment from <u>September 6, 2016 to September 26, 2016</u>.
