The Council will also receive for first reading Ordinance 17-xx, the title being: "AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF COSTA MESA, CALIFORNIA, AMENDING TITLE 5, CHAPTER 1, TABLE R301.2(1) OF THE COSTA MESA MUNICIPAL CODE BY ESTABLISHING THE ULTIMATE DESIGN WIND SPEED TO BE UTILIZED FOR THE DESIGN OF RESIDENTIAL STRUCTURES AS REQUIRED BY THE 2016 CALIFORNIA RESIDENTIAL CODE AND FURTHER ESTABLISHING THAT THE CITY OF COSTA MESA IS NOT WITHIN EITHER A SPECIAL WIND REGION OR A WIND BORNE DEBRIS ZONE".
