The proposed helistop was approved in 2011 by the Airport Land Use Commission (ALUC) and the Federal Aviation Administration (FAA). The project was considered by the Planning Commission on September 28, 2015, and it recommended approval of the project to the City Council, which approved the project on November 3, 2015. If approved, the time extension would be valid until November 3, 2017.
