**NOTICE IS HEREBY GIVEN** that a public hearing will be held by the Costa Mesa City Council at the regular meeting on **Tuesday, November 7, 2017 at 7:00 P.M.**, or soon thereafter as the matter shall be heard, in the City Hall Council Chambers, 77 Fair Dr., to request for review of Conditional Use Permits (CUPs) PA-17-19.

**Description:** Conditional Use Permits for a microbrewery (Brewing Reserve of California) operating past 11 PM within 200 feet of a residential zone with ancillary use of a tasting room and retail sales of beer produced on the premises and related products within a 3,000 sq. ft. tenant space. Proposed hours of operation for the microbrewery are Monday through Sunday, 5 AM to 5 PM; and proposed hours of operation for the tasting room / retail sales are Monday through Wednesday from 5 PM to 10 PM; Thursday and Friday from 5 PM to 12 AM; Saturday from 11 AM to 12 AM; and Sunday from 11 AM to 10 PM. The site address is 2930 College Avenue, Unit D; MG, General Industrial Zone. The applicant/Agent is Steven Aguilar.

**Environmental Determination:** The project is categorically exempt under Section 15301 of the State CEQA (California Environmental Quality Act) Guidelines (Class 1), Existing Facilities.
