AMENDMENT NUMBER ONE TO MAINTENANCE SERVICES AGREEMENT WITH BRIGHTVIEW LANDSCAPE SERVICES, INC.

This Amendment Number One ("Amendment") is made and entered into this 20th day of February, 2018 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and BRIGHTVIEW LANDSCAPE SERVICES, INC., a California corporation ("Contractor").

WHEREAS, City and Marina Landscape Maintenance, Inc. entered into an agreement on October 31, 2016 for Marina Landscape Maintenance, Inc. to provide park and landscape maintenance services on City property (the "Agreement"); and

WHEREAS, Contractor acquired the maintenance division of Marina Landscape Maintenance, Inc. in January 2017, resulting in the assignment of the Agreement to Contractor; and

WHEREAS, City consented to the assignment of the Agreement; and

WHEREAS, City and Contractor desire to amend the Agreement to reflect the assignment; and

WHEREAS, City and Contractor further desire to amend the Scope of Services to include the additional services and additional locations set forth in Exhibit "A," attached hereto and incorporated herein by this reference; and

WHEREAS, City desires to increase Contractor's maximum annual compensation accordingly to Two Million One Hundred Seventy-Nine Thousand Four Hundred Eighty-Six Dollars and Ninety-Nine Cents (\$2,179,486.99).

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. Any and all references in the Agreement to "Marina Landscape Maintenance, Inc." shall be amended to read, "BrightView Landscape Services, Inc."
- 2. Section 6.4 of the Agreement shall be amended to read:

3. The Scope of Services shall be amended to include the additional services and additional locations set forth in Exhibit A.

- 4. Section 2.1 of the Agreement shall be amended to reflect that Contractor's annual compensation shall not exceed Two Million One Hundred Seventy-Nine Thousand Four Hundred Eighty-Six Dollars and Ninety-Nine Cents (\$2,179,486.99). Contractor shall be paid according to the fee schedule set forth in the Agreement and Exhibit A of this Amendment.
- 5. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 6. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
