  - iii. A roundtable discussion was conducted on a FiPAC Budget Sub-Committee letter to City Council containing comments and recommendations on the FY 2018-19 Preliminary Budget. Ralph Taboada said Budget Sub-Committee would compile the Committees' comments into a final letter and forward the letter to the City Council ahead of the May 29, 2018 City Council Study Session.
- b. Sub-Committee report on collection of sales tax from OC Fairgrounds
  - Tammy Letourneau notified the Committee that Hinderliter, de Llamas & Associates (HdL) has been retained to review City sales tax collection issues. HdL will work with City staff and the FiPAC Sales Tax Sub-Committee to review current work performed and scope out the study.
