## 9a. Youth Sports Program Cost Recovery Category Change and Establishment of Fees

Ms. Jana M. Ransom presented the report.

Discussion between Commissioner Kim Pederson and Ms. Ransom occurred on whether or not the coaches are volunteers or employed by the City.

Commissioner Kim Pederson suggested that staff recruit volunteer coaches by contacting the local high schools.

Discussion between Chairman Kurt M. Galitski and Ms. Ransom took place on provisions that will allow underprivileged children to enroll in the youth sports program.

Chairman Kurt M. Galitski invited Mr. Mark Arblaster (President, Newport-Mesa Soccer Club) to speak about his organization's scholarship process.

Discussion between Ms. Ransom and Mr. Arblaster ensued on whether or not the Newport-Mesa Soccer Club practices sweat-equity in their organization.

Discussion between Chairman Kurt M. Galitski and Ms. Ransom occurred on possibly offering scholarships for ten children per league.

Discussion between Commissioner Kim Pederson and Ms. Ransom took place on having staff reach out to the local organizations and community foundations for assistance and to incorporate this in a recommendation.

Public comment was requested by Chairman Kurt M. Galitski. No public comments were received.

Motion made by Commissioner Jeff R. Mathews, seconded by Commissioner Terry Shaw and carried five to zero, to receive and file the report.

Galitski, seconded by Commissioner Kim Pederson and carried five to zero, for staff to review possibilities to provide a scholarship/grant program, either subsidized or provided for by the City, for the Youth Sports Program (Flag Football and Basketball) at the next Commission meeting.

# 9b. Impact of Budget Adoption

Mr. Peter Naghavi presented the report.

Discussion between Chairman Kurt M. Galitski and Mr. Naghavi ensued on the process for calling an emergency or special Commission meeting.

Discussion between Chairman Kurt M. Galitski and Mr. Naghavi occurred on possibly setting a minimum number of items to be placed on the agenda in order to determine if a meeting will be cancelled.

Discussion between Commissioner Jeff R. Mathews and Mr. Naghavi took place on whether or not there is a requirement for the Commission to hold a meeting regardless of the number of items on the agenda.

Discussion between Chairman Kurt M. Galitski and Mr. Naghavi ensued on the process to notify the public of a special meeting.

#### Public Comment:

Discussion between Mr. Arblaster and Mr. Naghavi occurred on the effective date for the change of the Commission meeting schedule, and on the required timeframe for an item to be placed on the agenda.

Discussion between Chairman Kurt M. Galitski and Mr. Naghavi ensued on the Commission calling for a special session/meeting, and on the notification process to hold a special session/meeting.

Discussion between Chairman Kurt M. Galitski and Ms. Ransom took place on the Commission addressing items on a routine nature in order to accommodate the new meeting schedule made by the City Council.

Discussion between Chairman Kurt M. Galitski and Mr. Naghavi occurred on whether or not a member of the public is able to request for the Commission to hold a special session/meeting at a City Council meeting, or if City Council can direct the Commission to hold a special session/meeting.

Commissioner Terry Shaw stated that he believes that meeting on the third Wednesday in November may not always work, and he recommended that staff plan accordingly.

Discussion among Commissioner Terry Shaw, Chairman Kurt M. Galitski, and Mr. Naghavi occurred on holding the regular November meeting on the third Wednesday in November.

Motion made by Chairman Kurt M. Galitski, seconded by Commissioner Jeff R. Mathews and carried five to zero, to approve the following:

- 1. Designate odd months for the Parks and Recreation Commission meetings.
- 2. Designate the third Wednesday in November each year as the official designated regular meeting date.
- 3. Designate the March meeting for the Annual Parks and Recreation Commission election and Committee assignments.

Motion made by Chairman Kurt M. Galitski, seconded by Commissioner Kim Pederson and carried five to zero, for staff to determine legal alternatives and processes for the Commission to hold a special session/meeting; to be reviewed at the next Commission meeting.

Chairman Kurt M. Galitski commended Mr. Hartley for his enthusiasm and follow through with the water wise garden projects.

# 11. <u>Commissioner's Comments</u>

Commissioner Terry Shaw announced that the Estancia Adobe renovation project is complete and that it is now open for viewing and tours on the 1<sup>st</sup> and 3<sup>rd</sup> Saturday of each month and by appointment.

Commissioner Terry Shaw thanked staff.

Commissioner Terry Shaw also announced that the Historical Society Annual Adobe Open House event will be on Saturday, September 19, from 10:00 a.m. to 2:00 p.m. at Estancia Park.

Commissioner Terry Shaw commended staff for their wonderful work on highlighting historical homes in Costa Mesa, which airs on Costa Mesa TV24. He also mentioned that the Civil War Reenactment, which was held at Fairview Park, is available for the public to view on the City's website at <a href="https://www.ci.costa-mesa.ca.us">www.ci.costa-mesa.ca.us</a>.

Commissioner Terry Shaw invited the community to the Orange County Fair that is ongoing. He also extended an invitation for the community to attend the 2009 Summer Concerts in the Park Series scheduled for July 28-August 18 at Fairview Park on Tuesday evenings from 6:15 p.m. to 7:45 p.m., which was made possible by donations from the Costa Mesa Community Foundation, Costa Mesa Firefighters Association, and the Costa Mesa Police Association.

Discussion between Commissioner Jeff R. Mathews and Mr. Hartley ensued on the recent budget reductions by the City Council for the Streetscape and Median Development Standards in reference to future tree removal requests.

Commissioner Kim Pederson said that donations, for the 2009 Summer Concerts in the Park Series, were also made by the Costa Mesa Cultural Arts Committee, the Foley Law Group, and the Daily Pilot. He also announced the schedule for the concert is as follows: July 28-Incedio (Classical Guitar); August 4-Steele Parade (Steel Drum); August 11-The Fabulous Nomads (Surf Band); and, August 18-The Slim Tones (Blues Rock).

Vice Chairman Mike Brumbaugh commended Walter Garcia for spearheading community safety and unity with help from neighbors along Baker Street and support from MICA.

Vice Chairman Mike Brumbaugh extended an invitation to the community to the Baker/Halecrest & Hall of Fame Community Party, which is part of the 2009 National Night Out event, scheduled for Tuesday, August 4, from 6:00 p.m. to 9:00 p.m. at Harbor Trinity Church (1230 Baker Street).

Vice Chairman Mike Brumbaugh also invited the community to the 5<sup>th</sup> Annual Halecrest & Hall of Fame Chili Cook-Off on Saturday, August 22, from 2:00 p.m. to 5:00 p.m. at Halecrest Park (3107 Killybrooke Lane). Discussion between Chairman Kurt M. Galitski and Mr. Hartley occurred on whether or not there is a process in place for community involvement, such as a tree planting program.

Chairman Kurt M. Galitski said that the Newport Boulevard/Old Town Costa Mesa Dedication Ceremony was fantastic.
