Senior Commission

The Senior Commission functions as an advisory body to the City Council and is authorized by Ordinance 14-14 to make such studies, investigations and hold public hearings as it may deem necessary for the formulation of policies or to determine the wisdom and efficiency of existing policies, plans and procedures, or to determine an action program to pursue the implementation of the City of Costa Mesa and report its finding and recommendations to the City Council, the Asst. City Manager, and/or the City Manager.

Public Comments – Matter Not Listed On The Agenda: If you wish to address the Senior Commission on a matter not on the agenda, please complete and submit a green speaker card to the Commission Secretary. Speaker cards must be submitted prior to the Public Comment period. Each speaker is limited to three minutes.

Public Comments – Matter Listed On The Agenda: If you wish to address the Senior Commission on a matter listed on the agenda, please complete and submit a green speaker card to the Secretary prior to the start of Public Comments on the item. Please identify which item on the agenda you would like to address. Each speaker is limited to three minutes.

Speaker cards are located on the table at the entrance of the meeting room. The Chairperson will call speakers to the podium in the order the blue speaker cards were submitted.

For each item on the agenda, staff will present a brief description and a recommendation. The Commissioners will then have the opportunity to question staff regarding the Staff Report and the recommendation. The applicant or authorized agent will then be invited to make a presentation and to respond to any questions from the Commission. Members of the audience wishing to speak regarding the issue will then be invited by the Chairperson to provide testimony. At the conclusion of the public testimony, the Chairperson will close the public comments and the Commission will discuss and take action on the recommendation. No additional testimony may be given after the public comments period is closed.

Those wishing to speak on an item are asked to come forward and to state their name and address for the taped record.

It is the intention of the City of Costa Mesa to comply with California Government Code Section 54961 and the Americans with Disabilities Act ("ADA") in all respects.
