1. GENERAL PLAN SCREENING REQUEST (GPS-18-01) FOR A MIXED-USE DEVELOPMENT ON A 15.23-ACRE SITE LOCATED AT 1683 SUNFLOWER AVENUE NORTH OF THE I-405 FREEWAY

Development Services Department/Planning Division

RECOMMENDATION:

City Council direct staff whether or not to process a General Plan Amendment request for development of a 15.23-acre parcel with 1,057 residential units, 6,000 square feet of specialty retail space, a 25,000-square-foot office building, and 1.7 acres of park/open space. The General Plan Screening (GPS) is the first step to start the process of submittal for a General Plan Amendment, Specific Plan, and a Master Plan application for development of the site. Staff recommends the following factors be considered in evaluation of this request. The project would:

- Allow a mixed use development with a site-specific density of up to 80 dwelling units per acre in close proximity to the freeway.
- Create a new mix of land uses which would provide more housing close to employment centers and improve the City's jobs/housing balance.
- Allow additional housing opportunities to meet the City's housing needs and potential affordable housing requirements allocated with the next Regional Housing Needs Assessment (RHNA) cycle.
- Reduce the City's overall industrial land use area by 15.23 acres.

2. APPROVE THE ACQUISITION OF REAL PROPERTY LOCATED AT 3175
AIRWAY AVENUE, COSTA MESA, CA 92627 FOR EVALUATION OF USE AS
THE CITY'S PERMANENT BRIDGE SHELTER AND OTHER POSSIBLE USES
