SUBJECT: FY 2019-20 Business License Administrative Processing Fee Supporting Information

The purpose of this memo is to provide additional support and information pertaining to the proposed administrative processing fee for businesses licenses for FY 2019-20.

Background

The City utilized several balancing measures in developing the FY 2019-20 Preliminary Operating and Capital Improvement Program Budget. One of those measures included the review of all existing operations to evaluate efficiencies and ensure existing fees were fully recovering costs. As such, the Finance Department also applied this approach when reviewing potential new fees to evaluate if there were existing operations and processes that did have full cost recovery. This evaluation led the department to propose new fees relating to the administrative processing of business licenses as well as propose funding in the FY 2019-20 budget for a full City-wide Fee Study to ensure that taxpayers are not subsidizing services and processes particularly related to development or businesses.

Analysis

The Finance Department is proposing a new administrative processing fee for business licenses, which is a fee comparable to other agencies that the City is not currently assessing. The maximum business license fee is \$200, even for the largest businesses. At this time, it takes almost two full-time positions to manage the business license program. Annually, these positions process approximately 2,000 new business licenses, 11,000 renewals, changes, amendments, or reactivations, and 1,500 reprints. The proposed fee increases are summarized below based on the type of administrative processing:

Business License Administrative Processing Charge	
Changes and amendments - existing accounts	\$25
Reactivations - existing accounts	\$35
Reprint fee	\$10
Delinquent payment penalty	25% per month; not-to- exceed 100% of the fee
Noncompliance penalties:	
After 90 days for renewals	\$50
After 45 days for New Applicants	\$50

Based on these estimates, the projected increase in revenue from this new fee is approximately \$250,000 in FY 2019-20. Consequently, this fee would ensure full cost recovery for such processes and prevent taxpayers from subsidizing businesses. Staff is also recommending the City Council authorize an annual increase in this type of fee by a minimum of CPI to ensure the fees fully recover costs as salary and benefits and the cost of doing business increase.
