IV. PUBLIC COMMENT

Shiloh Godshall, Costa Mesa, reported prostitution at the intersection of Harbor Blvd. and Gisler St. and requested the city's intervention to eliminate the problem.

V. COUNCIL MEMBERS' REPORTS, COMMENTS, AND SUGGESTIONS

Council Member Katrina Foley reiterated the approval by Council to move forward with the purchase of the fairgrounds and thanked staff for their efforts in preparing the documentation; announced that she and Council Member Monahan were going to Sacramento to deliver the proposal; and encouraged the public to continue making contact with the governor's office to implore him to make a deal with the city.

Council Member Gary Monahan reported the success of the Costa Mesa United Mesa Verde Golf Classic and encouraged those that might be interested in being involved in next year's event to contact Costa Mesa United.

Mayor Pro Tem Wendy Leece also noted the success of the Costa Mesa United Mesa Verde Golf Classic and reported that Ed Fawcett of the Costa Mesa Chamber of Commerce was recognized as the 2010 Honoree; announced that the next Citizen's Emergency Response Team (CERT) training sessions would be held on April 30-May 2, 2010; and indicated that Frequently Asked Questions relative to group homes was available on the city's website and asked staff to follow-up on business license requirements for group homes.

Mayor Mansoor entered the meeting at 6:28 p.m.

Mayor Mansoor noted that a request had been made to take New Business Item No. IX-4 out of order.

Council Member Foley and Mayor Pro Tem Leece expressed concerns that those interested in addressing the item may not yet be present at the meeting expecting that it was to be heard later, therefore suggested that it be heard after 7:00 p.m.

4. <u>Request from Council Member Monahan for consideration of proposed</u> <u>changes in regulation of fireworks.</u>

Council Member Monahan presented the staff report and noted there had been a number of youth groups interested in selling handheld devices such as sparklers and extending the sale of fireworks from 8 p.m. to 9 p.m. on the July 4th.

John Rubright, Costa Mesa, AYSO 120 representative, indicated that 70 percent of his organization's total fireworks sales were made are on the 4th of July, and therefore supported the extra hour for fireworks sales.

Ken Sanford, Costa Mesa, Estancia High School Football Booster Club, expressed appreciation to the Council for allowing the youth groups to sell fireworks, supported the additional hour for fireworks sales on the July 4th, and suggested that staff conduct research to see if other cities have had any problems with the sale of handheld devices.

Shiloh Godshall, Costa Mesa, indicated the cost of youth sports is increasing, and noting therefore that fundraising was necessary. She expressed support of the extra hour for fireworks sales.

Colin McCarthy, Costa Mesa, opined that fireworks was an important part of the city's culture, and supported the extra hour for fireworks sales and the use of hand-held devices.

Debbie Spear, Costa Mesa, Costa Mesa Aquatic Booster's Club Treasurer, expressed support for the extra hour of fireworks sales as well as the sale and use of sparklers.

Sandra Genis, Costa Mesa, spoke in opposition to the extension of the sale of

fireworks.

Darcy Wagner, Costa Mesa, expressed support of the extra hour of fireworks sales and the sale of "Morning Glories."

John Kelly, Fullerton, noted he works in the fireworks industry and provided background into the differences of sparklers and that of Morning Glories and addressed safety concerns. He also expressed his support in extending the fireworks sales for an extra hour.

Brian Harris, Costa Mesa, Fundraising Chair for the Youth Services Association of Orange County, reported that the fireworks stands are very busy in the last hour of sales on July 4th, and felt that the extra hour would not only earn extra money but reduce having to turn people away when closing the stands. He also asked that Council approve the sale and use of "Morning Glories."

Steve Mensinger, Costa Mesa, Pop Warner President and the Estancia Eagles Football President, stated that the sale of fireworks was an enormous revenue source for youth sports, and expressed support in allowing the extra hour for fireworks sales and the sale of handheld devices.

Beth Collins, Costa Mesa, supported the extra hour of fireworks sales.

Kathy Hoffstetter, Costa Mesa, supported the extra hour of fireworks sales but felt the primary issue was with those stands that continue to sell beyond the timeframe.

MOTION: Approve extending the closing of the fireworks stands to 9:00 p.m. on the 4th of July.

2. <u>Summer Concert Season Planning</u>

(a) Authorization of up to ten (10) hours of City staff time to work with the Costa Mesa Community Foundation Board of Directors to plan up to four concerts to be held at Fairview Park in July, 2010.

(b) Authorization of up to an additional forty (40) hours of City staff time to administer the 2010 Concert Series should the Costa Mesa Community Foundation secure donated funds to cover the direct costs.

(c) Authorize the Administrative Services Director to approve up to four (4) contracts with Reality Entertainment, not to exceed \$7,000 total, to provide bands and sound services for up to four (4) concerts if funding is secured by the Costa Mesa Community Foundation sufficient to cover the full direct costs of the concerts.

Bill Turpit, President of the Costa Mesa Community Foundation, presented the staff report and indicated that the Foundation had identified the Concerts in the Park as a community pride initiative, and therefore approved the allotment of \$7,000 for two concerts and committed to the raising of funds for the other two concerts for the summer series.

Recreation Manager Jana Ransom responded to questions regarding staff time required in the organizing, music licensing, the use of a promoter and the use of community talent.

Mike White, Costa Mesa, offered to work with the city in presenting a Christian music concert.

Jennifer Christ, Costa Mesa, Costa Mesa Community Foundation member, expressed her support in hiring of a promoter and pointed out that a promoter typically bring bands or audiences that would not generally participate, in addition to relieving the city of contract liability concerns.

MOTION: Authorize up to ten (10) hours of City staff time to work with the Costa Mesa Community Foundation Board of Directors to plan up to four concerts to be held at Fairview Park in July, 2010; and approve authorization of up to an additional forty (40) hours of City staff time to administer the 2010 Concert Series should the Costa Mesa Community Foundation secure donated funds to cover the direct costs.

Moved by Council Member Katrina Foley. Motion died for lack of second.

Council Member Bever expressed his support in allowing for the

Community Foundation to organize the summer concert series. He felt that as the Foundation had a working plan to fund the concert series and to hire an events planner for organizing the events, that devoting staff time was not necessary.

MOTION: To provide the park and the necessary facilities and to authorize the Costa Mesa Community Foundation to plan and organize the 2010 Concerts Series of up to four (4) concerts, with funding secured by the Foundation sufficient to cover the full direct costs of the concerts. Moved by Council Member Eric R. Bever. Motion died for lack of second.
