PRESENTATIONS

The Mayor presented the Mayor's Award to Ed Baume and Chuck Perry for their contributions and the countless hours that they both have donated to the community and youth sports.

IV PUBLIC COMMENTS

Sue Lester, Costa Mesa, spoke on behalf of the residents of the 700 block of Center Street who expressed their concerns regarding street conditions, criminal activity, police response times and asked for information regarding neighborhood watch.

Allen Rieckhof, President, Costa Mesa Police Association, addressed an alleged incident involving Planning Commissioner Jim Righeimer and Costa Mesa Police Officers at a Driving Under the Influence (DUI) checkpoint, requested that the Council initiate an investigation into possible abuse of authority and requested that the report be made public.

Dana Potts, Vice-President of the Costa Mesa Police Association, recounted his story where his life, as well as the lives of his wife and unborn child, were affected by a drunk driver. He spoke to the incident at the DUI checkpoint and of the importance of those checkpoints.

Vicky Macia, Victim Advocate for the Orange County Chapter of Mothers Against Drunk Driving (MADD), congratulated the Costa Mesa Police Department for recently acquiring the OTS STEP Grant to conduct further DUI projects, used in the successful deterrence of people who drink and drive.

Patty Moulton, representative of the Orange County Chapter of the Alzheimer's Association, spoke about Alzheimer awareness and announced upcoming fundraisers.

Peter Boyd, Costa Mesa, shared his story in the apprehension of a burglar in his neighborhood, expressed concerned regarding reductions in public safety and encouraged Council to make it a priority.

Ed Guilmette, Costa Mesa, opined of mismanagement on the Mesa Consolidated Water District, spoke of concerns regarding his water bill, and the funding of a

loan to retrofit the water plant.

Jay Photoglou, Huntington Beach, referred to an investigation he was involved in and asked for a response to the public records requests he had filed.

Chris McEvoy, Costa Mesa, encouraged Council to support Council Member Foley's recommendation to allocate 10 percent of the one percent increase of the Business Improvement Area toward youth programs and community services.

John Feeney, Costa Mesa, referencing the proposed Graffiti Ordinance discussed at a previous study session requested clarification in addressing, separately, specific aspects of the proposed ordinance.

Judi Berry, Costa Mesa, referred to the lease agreement for the Fairgrounds and supported Council Member Foley's dissenting vote, and expressed concern regarding campaign signs in the public right-of-way.

Martin H. Millard, Costa Mesa, suggested charging reasonable rates for field use and to allot the funds to the ROCKS program.

Sandra Genis, Costa Mesa, expressed concern regarding campaign signs in the public right-of-way, spoke in support of the police department and the DUI checkpoints.

Mike Berry, Costa Mesa, complained of noise from Triangle Square, and opined that Costa Mesa residents should not be charged for using the fields for youth sports.

Council Member Foley thanked Officer Potts for sharing his personal story where his life was directly effected by a drunk driver; referred to a public speaker's public records request; informed that Group 1 Users are comprised of 80 percent residents and therefore expressed opposition to increasing user fees; and addressed posted campaign signs as they relate to her own campaign.

Mayor Pro Tem Wendy Leece thanked former Mayor Jack Hammett for his work with the Freedom Committee; expressed support for the DUI checkpoints, commenting that they serve as a deterrent to drunk driving; and asked the City Manager to investigate the confrontation between a Planning Commissioner and police personnel at a checkpoint; and noted that a follow-up report was conducted regarding noise from Triangle Square.

Mayor Allan Mansoor responded to a public speaker's comments advising that specifics of the proposed Graffiti Ordinance could and would be discussed separately; and referenced the DUI checkpoint incident, noting that the City Attorney's office was conducting an investigation as to any impropriety.

Discussion amongst the Council and staff ensued regarding the current need to replace the vehicles.

Martin H. Millard, Costa Mesa, expressed opposition in the purchase of the vehicles.

(Speaker name not provided), offered information on the mechanical issues with the hybrid vehicles and therefore asked that Council consider the use of natural gas vehicles.

Beth Refakes, Costa Mesa, questioned the cost savings in the use of hybrid vehicles and opined that the expenditure was not warranted given the budget crisis.

Mayor Pro Tem Leece supported the reduction in the number of vehicles in the fleet.

Council Member Bever noted that while the City was not required to purchase strictly hybrid vehicles, it was a Council Policy, and agreed that replacement vehicles must have greater efficiency than the vehicles being replaced.

VIII OLD BUSINESS

1. Request for rehearing by Sandra L. Genis regarding the City Council adoption on August 24, 2010 of Resolution No. 10-62: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COSTA MESA, CALIFORNIA, FINDING THE PROPOSED LEASE AGREEMENT FOR THE ORANGE COUNTY FAIR AND EVENT CENTER TO BE

CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT.

Sandra Genis indicated that there was new information regarding historical resources that was not available at the time that the vote was taken, which indicated that the buildings were valuable historical resources and that two of the sites were less than 5,000 square feet which made them eligible for demolition. She noted that there was discussion regarding future intent subsequent to the action on categorical exemption to address portions of the development on an individual basis, which was contrary to the provisions of CEQA, and that the lease was "in a state of flux" at the time the categorical exemption was adopted.

The City Attorney responded to questions from the Council which included the ability for the buildings in question to be registered as historical buildings.

In response to an inquiry of the Mayor the City Attorney indicated that she believed the City had complied with, and addressed Ms. Genis' concerns, and clarified that the exemptions were for current uses on the site only.

Greg Ridge, Costa Mesa, opined the necessity for compliance with CEQA and suggested more time to address CEQA concerns relative to the exemptions.

Judi Berry, Costa Mesa, indicated her support for the rehearing noting her concerns relative to the exemption to CEQA requirements.

Beth Refakes, Costa Mesa, expressed concern regarding protection in maintaining the historical structures.

would function if the homeowner was to give the house away or other similar type of arrangements.

Celeste Brady, Special Housing Consultant, indicated that if the property was sold by the original buyer during the 45-year period, the original principal amount would be due, and confirmed that starting year 31, the 1/15th of the principle would be forgiven.

John Feeney, Costa Mesa, expressed his opposition to the program and suggested that Council discontinue the program.

Martin H. Millard, Costa Mesa, expressed opposition in the Neighborhood Stabilization Program.

Ernie Feeney, Costa Mesa, expressed concern regarding the length of time of the mortgage, noting her opposition to the proposal.

Ben Phillips, Regional Director and Vice President of Mercy Housing, Southern California, provided an overview of the organization.
