CLOSED SESSION REPORT

The City Attorney reported that no action was taken on the closed session items.

PRESENTATIONS - Mesa Consolidated Water District 50th Anniversary Proclamation

The Mayor presented a proclamation to the Mesa Consolidated Water District in recognition of its 50th Anniversary.

IV PUBLIC COMMENTS:

Nicole Duran, Costa Mesa, opined that "Costa Mesa is a safe place to live," and therefore did not support the reductions in public safety and the Fire Department.

Winston Ochsenbein, Costa Mesa, opposed reductions in the Police Department due to budget cuts.

Julie Ochsenbein, Costa Mesa, cautioned and opposed the reduction in public safety personnel due to the budget cuts.

Kathleen Daly, Costa Mesa, felt that public safety and housing should be priority

commenting that everyone deserves a place to live.

Gary Parkin, Costa Mesa, thanked Council for their hard work during tough economic times, stated he felt safe in his neighborhood, thanked staff for removing the trees along Fairview Road, and asked what the City could do regarding the excessive number of handbills in the mail.

Eloise Ott, Costa Mesa, expressed concern regarding litter on the freeway.

Celeste Ames, Costa Mesa, complained of an increase of business deliveries in her neighborhood at hours outside of what is permitted by code. She also reported parking in the red zone at the shopping area located at 17th Street and Tustin Avenue, which causes unsafe conditions when exiting the parking area.

Walter O. Garcia, Costa Mesa, expressed support for the police department.

Jay Photoglou, Huntington Beach, referred to an incident he was involved in and requested the Council direct the City to conduct an investigation of his complaint and to submit the results.

Chris McEvoy, Costa Mesa, inquired as to what would happen to the Council seat if Council Member Foley is elected to the school board.

Sue Lester, Costa Mesa, expressed concern regarding access to resources for seniors.

Sandra Genis, Costa Mesa, encouraged voters to support the Transient Occupancy Tax increase (Measure C).

Beth Refakes, Costa Mesa, requested an update regarding the Fairgrounds, and inquired on the availability of the City Attorney's report regarding the DUI checkpoint incident that had occurred a few weeks prior.

Cindy Brenneman, Costa Mesa, spoke about breast cancer awareness and the Race for the Cure, and thanked Costa Mesa Police Department personnel for their participation, representation, and support.

V COUNCIL MEMBERS' REPORTS, COMMENTS, AND SUGGESTIONS

Mayor Mansoor corrected a statement made by a public speaker relative to an alleged salary increase by the Council and addressed a public speaker's concerns regarding recusal for decisions relative his case.

Council Member Foley acknowledged the Costa Mesa High School cheer squad for their involvement with breast cancer awareness; announced her attendance at the Costa Mesa High School Aquatics Center opening; asked for donations to assist in equipping the snack bar at the Tewinkle Sports Complex for fundraising opportunities; noted meetings with Caltrans where trash on the freeways were addressed with little response due to budget constraints; and requested an update and options of legal remedies regarding the sale of the Fairgrounds.

The City Manager indicated that there was not legislation at this time moving forward in the City's bid in the sale of the Fairgrounds. He noted that the governor again authorized the Fairgrounds to be placed up for bid and that the State had receive multiple bids at the close of the process. He noted the States intent to proceed with the sale of the Fairgrounds in a process that did not require legislation in order to sell it.

Council Member Monahan requested staff to provide a full written report regarding Mr. Photoglou's concerns and any public records requests made.

Mayor Pro Tem Leece announced the upcoming Fire Station open house; recognized the Costa Mesa Women's Club 100th year anniversary; reported her involvement with the Orange County Division of the California League of Cities and expressed the collective interest to protect local control; commented about public safety and urged residents to contact Council with any concerns regarding public safety; acknowledged homeless issues; and responded to public speakers' concerns regarding code enforcement of the trucks, distribution of flyers, and of litter.

Genis regarding the Joint Powers Authority adoption on September 7, 2010 of Resolution No. 10-2: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COSTA MESA, CALIFORNIA, A JOINT POWERS AUTHORITY FINDING THE PROPOSED LEASE AGREEMENT FOR THE ORANGE COUNTY FAIR AND EVENT CENTER TO BE CATEGORICALLY EXEMPT FROM THE CALIFORNIA ENVIRONMENTAL QUALITY ACT.

The City Attorney introduced the request for rehearing and indicated that there was language added to the draft lease, in which the tenants expressly acknowledges that no demolition of any structures identified on Exhibit "L" shall occur on the premises except in an emergency until the tenant has processed and obtained approval of a master plan or specific plan for the site with the City, and demolition of other structures may require discretionary review.

Sandra Genis expressed concerns regarding the 22 mitigation measures, and felt that without all of the mitigation measures included in the lease, there would be an impacts. She also noted that while CEQA review is necessary for all new development that it should not be done in a "piecemeal" manner.

The City Attorney addressed items of concern listed in the request for rehearing and responded to questions from the Council regarding the Exclusive Negotiating Agreement (ENA), confirmed that indeed the lease or the Memorandum of Understanding did not include language restricting Facilities Management West who was in exclusive negotiating agreement with the City in the lease and operation of the Fairgrounds, from submitting a bid in response to the State's Request for Proposals in the sale of the Fairgrounds, as well as protections of the "historical" buildings of the property and thereby re-read the new language into the record included in Exhibit "L" regarding any demolition of those structures.

Sandra Genis, Costa Mesa, opined that the lease should have been finalized when it was initially submitted and approved, and expressed concern regarding not only the outstanding details but also of the Quitclaim deed, felt that it inadequately addressed the use of the grounds by the Federal in the a state of an emergency and felt that community uses should be occurring at a time that is agreeable to all parties.
