PRESENTATION - Public Services Department Presentation on Capturing \$3.5 Million in Grant Funding

City Engineer Ernesto Munoz presented an overview of the recent grants totaling \$3.5 million recently acquired by the Public Services Department for various City projects.

IV PUBLIC COMMENTS

Sue Lester, Costa Mesa, thanked City staff for their involvement in aiding a senior citizen, and encouraged Council to investigate providing greater resources to the senior community.

Damian Stafford, Secretary to the Costa Mesa Police Association, and a member of the negotiating team commended the City's negotiation team and summarized their efforts in reducing personnel costs to the city.

Allen Rieckhof, President of the Costa Mesa Police Association, informed the Council of history of high standards of the Costa Mesa Police Department; noted their primary objective for public safety and reminded of their effectiveness and benefit to the community.

Steve Deck, Costa Mesa, expressed concern of the conditions of the West Side, and suggested the elimination of locations which may be magnets for transients to the area.

Joseph Yashar, Costa Mesa, suggested the banning of marijuana and cigarette smoking in apartment communities noting health and safety concerns.

Peter Metler, Costa Mesa, requested extension of the time that campaign signs could be consistently posted suggesting from the end of October through election day.

Wendell Mitchell, Costa Mesa, thanked the Costa Mesa Police Department for offering the ride-along program, and shared his positive experience.

Rex Tompkins, Costa Mesa, expressed his concern regarding the focus of employee salaries, opined that it was misleading when compared with neighboring cites and noted the value to the community to hire the best. He also was not supportive of eliminating revenue generating positions.

Tim Vasin, President of the Costa Mesa Firefighters Association, addressed statements made by a Council Member, emphasizing the commitment of the firemen to their jobs.

Sandra Genis, Costa Mesa, encouraged residents to vote for Measure L, and to contact the governor's office to stop the sale of the Fairgrounds.

Julie Oshmy, Costa Mesa, noted her support of the Police Department and informed of their valued assistance at the Developmental Center with the children with disabilities.

Terry Shaw, Costa Mesa, representing the Costa Mesa Historical Society, announced the upcoming event featuring Gordon Bricken, author of "Pioneers in Blue and Grey: Civil War Veterans in Orange County," and also announced a fundraiser at Newport Rib Company on November 2, 2010, in which a portion of the proceeds would benefit the Historical Society.

Lauren Snyder, Costa Mesa, expressed her support of the Costa Mesa Police Department, shared her own experience and noted their effectiveness and importance to the community.

John Hawley, Costa Mesa, thanked Council and staff for their efforts on the graffiti ordinance.

Cindy Brenneman, Costa Mesa, thanked members of the Costa Mesa Fire Department and Costa Mesa Police Department for their participation in breast cancer awareness month and commented on the importance and service of excellence by the departments.

PUBLIC HEARINGS

1. PUBLIC HEARING: Continued from the meeting of September 7, 2010, Appeal of the Planning Commission's determination regarding Zoning Applications ZA-89-25 and ZA-92-10, for review, modification, and/or revocation of Minor Conditional Use Permits for a recycling center with a maximum of two containers in a commercial shopping center, located at 739 W 19th Street, in a C1 (Local Business District) zone. Environmental determination: Exempt.

Senior Planner Mel Lee summarized the staff report.

Patricia Chen, Miles Chen Law Group, counsel for Garcia Recycling, provided a timeline of events. She spoke to the citations that had been corrected, addressed landscaping and the parking issues and argued that there were no violations of the Conditional Use Permit that warranted a revocation, nor time provided to correct the "violations".

The following residents spoke in support of upholding the Planning Commission's decision to revoke the Minor Conditional User Permit: Franca Carmona, Costa Mesa; Terrell E. Koken on behalf Manuel Schmotzer, Costa Mesa; Hailey Herbertz on behalf of Joyce P. Thomas, Costa Mesa, and Jeff Byrne, Costa Mesa.

Hildegard Gonzalez, Costa Mesa, felt the actions were long overdue and urged support to uphold the Planning Commission's determination.

Edward Carmona, Costa Mesa, read a letter he had written in October 1992 in opposition to enlarging the current operation and noted a hazardous egress and ingress.

Steven Chan, Costa Mesa, resides 200 feet from the facility and complained of the excessive noise from the facility.

Harrison Chan, Costa Mesa, felt that the Planning Commission acted appropriately in determining a public nuisance and that it was incompatible with the surrounding properties.

Steve Deck, Costa Mesa, expressed support in the relocation and commented that the operation had depressed the value of the area and affected the quality of life.

Danielle Bonilla, Costa Mesa, spoke on behalf of her father Victor Garcia, noting that the state, in 1989, had approached her father to place a recycling center in the area, spoke of their efforts to work with code enforcement and their neighbors, recognized a homeless issue but opined that the Soup Kitchen and liquor store had contributed to the increase of transient traffic to the location.

John Hawley, Costa Mesa, spoke in support of the Planning Commission's findings, and suggested relocation to the City's Corp Yard.

Sue Lester, Costa Mesa, spoke on behalf of residents who indicated that they did not have an issue with the recycling center, but rather the quality of life issues associated with the recycling center, and supported relocation.

Chris McEvoy, Costa Mesa, spoke in support of allowing the recycling center to relocate.

At the recommendation of the City Attorney the Mayor called for a recess to provide staff time to make copies of documents received during Public Comment, and to allow the Council and the appellant additional time to review the documents.

The Mayor recessed the meeting at 8:45 p.m.

The Mayor reconvened the meeting at 9:03 p.m.

Steven Miles, Miles Chen Law Group, counsel for Garcia Recycling, felt that the focus of the comments from the public was that of the glass from the recycling center, argued the findings for the revocation made at the Planning Commission hearing, informed that no previous code enforcement violations had been received, questioned the measurement for "excessive noise", commented on the concerns relating to odor, loitering and noise, and suggested additional time to address allogetions.

The City Attorney referred to CMMC Section 2-303(a), which indicated that the appeal hearing is based on "any relevant evidence, including staff reports, etc. submitted at the time of the prior decision and at the appeal hearing," and noted that it was appropriate to consider both the original findings and any new findings that Council may be considering based on the evidence.

Discussion ensued between the Council and Ms. Chen and Mr. Miles regarding the relocation of trucks, relocation assistance for the business, and noise reduction measures.

Mayor Pro Tem Leece referencing a letter from the Planning Division to Garcia Recycling, questioned their willingness to comply with the condition that required that all activity be conducted inside the container.

Ms. Chen commented that their interpretation was that the condition stated that all materials must remain inside the container, not activity.

Council Member Foley expressed reservations relative to the process but recognized the concerns of the residents while trying to balance the interest of the business.

Staff responded to questions from the Council Member regarding the interpretation of a provision that "all materials shall remain inside the containers."

In response to Mayor Pro Tem Leece's question the City Attorney advised of the options available to the Council relative to the determination and the ability for adding additional findings and or conditions.

MOTION: Uphold the Planning Commission's decision to revoke the minor conditional use permit, directed the City Attorney to prepare a resolution with amended findings. Moved by Mayor Allan R. Mansoor, seconded by Mayor Pro Tem Wendy Leece.

Council Member Foley asked the maker of the motion to add the specified time of six-month's to allow for relocation and transition.

Mayor Mansoor while not opposed to applicant working towards relocation

expressed his preference to leave the timeframe open and that it be define it at a later time. The City Attorney advised that direction as to time frame would be helpful when drafting the resolution.

Discussion ensued amongst the City Council regarding the permitting of transition time and relocation.

The Mayor amended his motion to include a three-month time period. Mayor Pro Tem Leece agreed to the amendment.

Council Member Monahan commented that he would support the motion, as he felt that the time was reasonable and it would allow an opportunity to review if progress was being made. He felt action was necessary opining that the impacts from the business had become too intense for the neighborhood.

Council Member Foley inquired as to the length of time Mr. Garcia would need to relocate the business.

Counsel for Garcia Recycling requested an opportunity to consult with Mr. Garcia.

The Mayor recessed the meeting at 9:57 p.m.

The mayor reconvened the meeting at 10:10 p.m.

Mr. Miles responded to a previous question regarding reducing of noise noting that there was a way to mitigate with the use of rubberized cushioning. He further requested that the relocation be kept separate from the revocation. He suggested a six-month time period to allow the appellant time to work with staff to find an alternative location.

Development Services Director Kimberly Brandt responded to questions from the Council regarding relocation and Conditional Use Permits. She clarified that it would be a Minor Conditional Use Permit, and the initial authority to review and approve was with the Zoning Administrator.

In response to Council Member Monahan's question relative to the possibility of a delay if there is sufficient "activity", the City Attorney confirmed that there could language included in the resolution, stipulating that if the 90-days proved to be insufficient, the appellant could make a request for a time extension.

MOTION: Uphold the Planning Commission's decision to revoke the minor conditional use permit, directed the City Attorney to prepare a resolution with amended findings, and directed staff to work with the applicant, providing 90 days in which to investigate a relocation of the business but with the option to extend, with Council approval, if sufficient progress has been made.

2. <u>Request of Council Member Monahan for adoption of a resolution</u> <u>supporting a ban on Dental Mercury.</u>

Council Member Monahan presented the reported, and introduced representatives of the California for Green Dentistry.

Anita Vasquez Tibau, Director of Californians for Green Dentistry, spoke in support of the ban, noting the dangerous effects of the use and of the dental mercury and presented a petition with signatures of those supporting the resolution.

Charles Brown, Executive Director, Consumers for Dental Choice and President, World Alliance for Mercury Free Dentistry, spoke in support of the ban on dental mercury, noting that amalgam is considered a household waste, is an environmental pollutant and is hazardous to our health.

Chester Yokoyama, DDS, spoke about his 23 years of experience as a

mercury-free dentist, and explained protections taken and the process for removing and handling of the amalgam.

Dr. James Rota, Los Angeles, spoke in support of the ban on dental mercury and expressed concern regarding the disposal of mercury from dental offices.

Marisa Russo, dental hygienist spoke in support of the ban on dental mercury noting its toxicity.

Carmella Costancio, Costa Mesa, encouraged Council to adopt the resolution and the supporting of a mercury free dental zone.

Mary Froemke, Costa Mesa, spoke against mercury based on her experience at a water purification store.

Brad Miller, Costa Mesa, supported the the resolution to ban the use of amalgam.

Christy Mills, Newport Beach, reported on various uses of mercury and the harmful effects of contamination, and spoke in support of the ban on dental mercury.

Fernando Santiago, molecular biologist, noted that there is no safe level of mercury exposure, and supported the Council's adoption of the resolution.

Stephanie Adamson spoke of her experience as a patient with dental mercury poisoning.

Dr. Ron Housepian, Costa Mesa, opined that the testimony regarding dental mercury might not be balanced, and opposed the resolution.

Speaker (name not provided) spoke in support of the resolution to ban dental mercury.

Beth Refakes, Costa Mesa, expressed support for the resolution if it was a simply a policy statement and not an enforceable policy.

Council Member Bever clarified that the resolution was for a voluntary compliance.

MOTION: Adopt Resolution No. 10-72.
