5. COMMITTEE MEMBERS COMMENTS

Member Bob Juneman noted that the word 'balanced' had been removed in the Adopted Budget version in describing the budget.

Member Al Melone spoke to reducing the Marijuana Tax from 6% to 2% in an effort to retain the industry locally rather than chase them out of the local area.

Member Wendy Leece spoke to needing additional information to justify the Marijuana Tax reduction, inquired on status of the 115 Trust, and noted that Newport Beach has been consistent in paying down pensions.

Member John Hinson spoke to two articles he sent, to be forwarded to the committee, regarding the cannabis industry, referencing legalization in California in 2016 where \$12 billion in sales was documented and in 2019, \$3 billion was legitimate as the taxes are driving people to the illegal market. Also spoke to the City of Huntington Beach considering purchasing Pension Obligation Bonds (POB's) and suggested someone coming in to educate the committee on the topic.

6. COMMITTEE CHAIR COMMENTS

Updated the Committee that K. Worgan is looking in to the possibility of merging Fire and Police pension plans for Costa Mesa.

Suggested that staff provide more information to the City Council with regards to Capital projects, similar to what is provided in the budget. i.e. budget, ITD expenditures, estimated costs of completion, comments, etc.

Spoke to John Hinson's comments on POB's and the topic being on the Huntington Beach Finance Commission's agenda as well as the new City Manager in Huntington Beach presenting the idea of POB's to their City Council. HB City Council wanted to know risks, savings, etc. involved. The Finance Staff is scheduled to have a draft procedure regarding POB's, at the Commission's January meeting.

Marcia Frost commented at a recent ACC/OC meeting on CalPERS weening off of ESG investment restrictions.

Presented financial charts with historical and trend data.

7. NEW BUSINESS

- a. Future Projects and Preliminary FiPAC meeting agenda items through May 2020
 Summary: Finance Director, Kelly Telford, reviewed the agenda matrix with the committee, pointing out topics for upcoming meetings.
- b. Appoint Subcommittee:
 - i. Tax Rates (TOT, Business License, Sales Tax, Short-Term Rentals)

 - iii. Pensions
 - iv. Budget (Capital and Operating)

Summary: The committee agreed to eliminate the Marijuana Gross Receipts Tax Committee and further, appointed Member, Wendy Leece, to be recommended by Mayor Pro Tem, John Stephens, to sit on an ad hoc committee to be formed by City Council. The committee tentatively formed subcommittees with updated members, to be voted on at the January 8, 2020 meeting.
