# MINUTES OF THE SPECIAL MEETING OF THE BIKEWAY AND WALKABILITY COMMITTEE

01-07-20

These meeting minutes represent an "action minute" format. The Bikeway and Walkability Committee of the City of Costa Mesa, California met in a special session at 6:15 p.m. on Tuesday, January 7, 2020.

#### 1. CALL TO ORDER

Vice Chair Ralph Taboada called the meeting to order at 6:15 p.m. at the Costa Mesa/Donald Dungan Library in the Adam's Room at 1855 Park Ave, Costa Mesa, California.

#### 3. PUBLIC COMMENTS

1. Resident who participated in a walk audit requested continuous sidewalks on Bernard Street between Harbor Boulevard and Maple Avenue. Comments included utility obstacles in sidewalks in this neighborhood.

- 2. Mesa Verde resident commented on an article in the Westways magazine (January/February 2020 issue) regarding the reduction of the number of vehicle travel lanes to add bike lanes. The resident is concerned about the bicycle project designs discussed in the article from Long Beach.
- 3. Planning Commissioner Marc Perkins provided an update to the committee on upcoming planning activities, Council Member Reynolds monthly bicycle ride, and the Orange Coast College's Flex Day and Sustainability Fair on February 20. The plans for the OCC Flex Day include Lime e-scooter demonstration on campus.

### 4. APPROVAL OF MINUTES

Member Bryan Estrada moved to approve the December 4, 2019 meeting minutes and member Richard Huffman II seconded the motion. The motion passed; 7 yes and 1 abstain.

#### 5. OLD BUSINESS

a. Class II and Class III Projects

Jennifer Rosales, Transportation Services Manager, provided an update on the Class II and Class III projects which includes ten Class III bicycle facilities as prioritized by committee members and Class II bicycle signing/striping modifications at three intersections. This project is in the public bid phase for construction. Bid opening is scheduled for February 10. Vice Chair Ralph Taboada is concerned about the budget and priorities between Class II and Class III bicycle facilities.

## 6. NEW BUSINESS

a. Bear Street Improvements

Transportation Services Manager, Jennifer Rosales, provided an update on the Bear Street improvements and request to Caltrans to approve proposed bike lanes in state right-of-way.

Marc Perkins, board member from the Costa Mesa Alliance for Better Streets (CMABS), presented the information provided in the letter from CMABS to the members of the committee.

Member Bryan Estrada moved to make a recommendation to the City Council that complete street design enhancements be incorporated into the Bear Street improvements and the design information identified in the letter January 6, 2020 from the Costa Mesa Alliance for Better Streets be considered for future design improvements to Bear Street. Member Flo Martin seconded the motion. The motion passed unanimously.

b. Capital Improvements Projects – Budget Requests for ATP Projects

Transportation Services Manager, Jennifer Rosales, presented a list of proposed projects from the Transportation Division for Fiscal Year (FY) 20-21 Capital Improvement Projects. Committee members suggested the following additional projects to be added to the list for consideration: Mesa Verde Drive East Class II Bicycle Lane between Adams and Harbor and Engineering Division's New Sidewalk/Missing Link and Sidewalk Repair projects.
