AMENDMENT NUMBER FOUR TO PROFESSIONAL SERVICES AGREEMENT WITH TOWNSEND PUBLIC AFFAIRS, INC.

This Amendment Number Four ("Amendment") is made and entered into as of the 20th day of March, 2020 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and TOWNSEND PUBLIC AFFAIRS, INC., a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on March 21, 2017 for Consultant to provide grant writing consulting services (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the Agreement for four (4) additional one (1) year periods; and

WHEREAS, on March 20, 2018, City and Consultant extended the Agreement through March 20, 2019; and

WHEREAS, on March 20, 2019, City and Consultant extended the Agreement through March 20, 2020; and

WHEREAS, on October 15, 2019, City and Consultant amended the Scope of Services and increased Consultant's maximum annual compensation to Seventy-Four Thousand Dollars (\$74,000.00); and

WHEREAS, Consultant has continued to provide the services to the City; and

WHEREAS, City and Consultant intend and desire to have this Amendment be retroactive to the Effective Date; and

WHEREAS, City and Consultant desire to extend the term of the Agreement for one (1) additional year, through March 20, 2021.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. This Amendment shall be retroactive to the Effective Date.
- 2. The term of the Agreement shall be extended through March 20, 2021.
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 4. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.

5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.
