

**AMENDMENT NUMBER ONE
TO PROFESSIONAL SERVICES AGREEMENT
WITH
CITYGATE ASSOCIATES, LLC**

This Amendment Number One ("Amendment") is made and entered into as of the 31st day of March, 2020 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and CITYGATE ASSOCIATES, LLC, a California limited liability company ("Consultant").

WHEREAS, City and Consultant entered into an agreement on August 6, 2019 for Consultant to provide Standards of Coverage assessment consulting services (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term ending March 31, 2020; and

WHEREAS, Consultant has continued to provide the services to the City; and

WHEREAS, City and Consultant intend and desire to have this Amendment be retroactive to the Effective Date; and

WHEREAS, City and Consultant desire to extend the term for fifteen (15) months, through June 30, 2021.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This Amendment shall be retroactive to the Effective Date.
2. The term of the Agreement shall be extended through June 30, 2021.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
4. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.
