## AMENDMENT NUMBER TWO TO PROFESSIONAL SERVICES AGREEMENT WITH SUPERIOR PAVEMENT MARKINGS, INC.

This Amendment Number Two ("Amendment") is made and entered into as of the 4th day of April, 2020 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and SUPERIOR PAVEMENT MARKINGS, INC., a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on April 5, 2016 for Consultant to provide street striping and thermoplastic roadway marking services (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of three (3) years, with the option to extend the Agreement for two (2) additional one (1) year periods; and

WHEREAS, on April 4, 2019, City and Consultant extended the term of the Agreement through April 4, 2020; and

WHEREAS, Consultant has continued to provide the services to the City; and

WHEREAS, City and Consultant intend and desire to have this Amendment be retroactive to the Effective Date; and

WHEREAS, City and Consultant desire to extend the term for one (1) additional year, through April 4, 2021.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. This Amendment shall be retroactive to the Effective Date.
- 2. The term of the Agreement shall be extended through April 4, 2021.
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 4. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
- 5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.
