AMENDMENT NUMBER TWO TO PROFESSIONAL SERVICES AGREEMENT WITH ROBERT BORDERS & ASSOCIATES

This Amendment Number Two ("Amendment") is made and entered into this 16th day of June, 2020 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and ROBERT BORDERS & ASSOCIATES, a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on July 2, 2019 for Consultant to provide architectural and design services in connection with the City's homeless shelter (the "Agreement"); and

WHEREAS, on October 1, 2019, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation to Three Hundred Seventy-Five Thousand Dollars (\$375,000.00); and

WHEREAS, City and Consultant desire to further amend the Scope of Services to include the additional services set forth in Exhibit "A," attached hereto and incorporated herein by this reference: and

WHEREAS, City desires to increase Consultant's maximum compensation accordingly to Four Hundred Five Thousand Dollars (\$405,000.00).

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The Scope of Services shall be amended to include the additional services set forth in Exhibit A.
- 2. Section 2.1 of the Agreement shall be amended to reflect that Consultant's total compensation shall not exceed Four Hundred Five Thousand Dollars (\$405,000.00). Consultant shall be paid according to the fee schedule set forth in the Agreement and Exhibit A of this Amendment.
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 4. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
- 5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.

- viii. Participate in pre-final and final inspections of the work to determine if the work is complete and in accordance with the Construction Documents.
- Prepare a set of reproducible record drawings (as-built) in PDF format showing significant ix. changes in the work made during construction based on marked-up prints, and drawings.
