AMENDMENT NUMBER TWO TO PROFESSIONAL SERVICES AGREEMENT WITH IBI GROUP

This Amendment Number Two ("Amendment") is made and entered into as of the 31st day of May, 2020 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and IBI GROUP, a California partnership ("Consultant").

WHEREAS, City and Consultant entered into an agreement on June 1, 2018 for Consultant to conduct a parking study for the South Bristol Entertainment and Cultural Arts (SoBECA) Urban Plan Area (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the Agreement for two (2) additional one (1) year periods; and

WHEREAS, on May 31, 2019, City and Consultant extended the term of the Agreement through May 31, 2020; and

WHEREAS, Consultant has continued to provide the services set forth in the Agreement; and

WHEREAS, City and Consultant intend and desire to have this Amendment be effective retroactive to the Effective Date; and

WHEREAS, City and Consultant desire to extend the term of the Agreement for one (1) additional year, through May 31, 2021.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- This Amendment shall be effective retroactive to the Effective Date.
- 2. The term of the Agreement shall be extended through May 31, 2021.
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 4. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
- 5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.
