In accordance with federal regulations [24 CFR 91], and applicable waivers made available through the Coronavirus Aid, Relief, and Economic Security Act of 2020 (CARES Act), notice is given that the City of Costa Mesa is making additional amendments to the 2015-2019 Consolidated Plan/2019-2020 Annual Action Plan.

#### **Amendment**

The 2015-2019 Consolidated Plan/2019-2020 Annual Action Plan amendments will enable the City of Costa Mesa to receive and administer \$1,168,874 in Community Development Block Grant - Coronavirus (CDBG-CV) Round 3 funding allocated to the City by the U.S. Department of Housing and Urban Development (HUD). The amendment will add Round 3 CDBG-CV funds to the 2019-2020 Action Plan for following activities:
