AMENDMENT NUMBER FOUR TO PROFESSIONAL SERVICES AGREEMENT WITH JOHNSON FAVARO

This Amendment Number Four ("Amendment") is made and entered into this 16th day of November, 2020 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and JOHNSON FAVARO, a California limited liability partnership ("Consultant").

WHEREAS, City and Consultant entered into an agreement on December 1, 2015 for Consultant to provide architectural services in connection with the construction of a new library and community center (the "Agreement"); and

WHEREAS, on July 30, 2018, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly; and

WHEREAS, on January 15, 2019, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly; and

WHEREAS, on April 26, 2019, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly; and

WHEREAS, Section 4.1 of the Agreement provides for an initial term through December 31, 2020, with the option to extend the term for one (1) additional two (2) year period; and

WHEREAS, City and Consultant desire to extend the term for two (2) years, through December 31, 2022.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The term of the Agreement shall be extended for two (2) years, through December 31, 2022.
- 2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 3. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
- 4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.
