

**AMENDMENT NUMBER FOUR
TO PROFESSIONAL SERVICES AGREEMENT
WITH
MICHAEL BAKER INTERNATIONAL, INC.**

This Amendment Number Four ("Amendment") is made and entered into this 16th day of February, 2021 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and MICHAEL BAKER INTERNATIONAL, INC., a Pennsylvania corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on March 19, 2019 for Consultant to provide environmental consulting services in connection with the One Metro West project (the "Agreement"); and

WHEREAS, on December 17, 2019, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly; and

WHEREAS, on May 29, 2020, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly, and acknowledged and agreed that funding for Consultant's services is provided by the One Metro West project applicant, Rose Equities LLC; and

WHEREAS, on February 2, 2021, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly; and

WHEREAS, the Agreement provides for an initial term of two (2) years, through March 18, 2021; and

WHEREAS, City and Consultant desire to extend the term of the Agreement for three (3) years, through March 18, 2024.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The term of the Agreement shall be extended for three (3) years, through March 18, 2024.
2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
3. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.
