# **PRESENTATIONS**

Officer Larry Seja of the Tustin Police Department and a volunteer with Mothers Against Drunk Driving (MADD) presented the MADD Deuce Award to Officers Jared Shurley and Crystal Rodriguez for their service to the community by apprehending 25 or more impaired drivers in 2009.

The Mayor recognized Mike Byrum, General Manager of Village Nurseries, Huntington Beach, and landscape designers Brooke Dietrich, Cherie Ciotti-Roco, Laura Dalton and Katie Cool for their donations of plants and design services for the design and installation of eight water-wise gardens that were planted around City Hall.

#### IV. PUBLIC COMMENTS

Sue Lester, Costa Mesa, supported the use of medical cannibus and asked that Council reconsider amending the current ordinance.

Dave Mason, Costa Mesa, supported the use of medical marijuana and reemphasized the importance of being able to purchase marijuana within the city.

Marla James, Costa Mesa, thanked the Mayor for meeting with medical marijuana supporters regarding the collectives, and requested Council to permit marijuana collectives to obtain business licenses.

Kandice Hawes, Lake Forest, was appreciative to the Mayor for meeting with medical marijuana supporters and was hopeful that the other Council Members could also meet with them in the future.

Tracie Neria, (no city provided), thanked the Mayor for listening to the concerns of medical marijuana supporters, and asked for Council's support in providing of safe access to medical marijuana.

Jonathan Hogo, Costa Mesa, supported medical marijuana dispensaries and asked Council to work with the collectives to make them legal and compliant.

Taylor Cannon, Costa Mesa, expressed the benefits in the use of medical marijuana and requested Council to consider an ordinance to allow dispensaries to exist with in the city.

Martin H. Millard, Costa Mesa, expressed concern over the distribution of monies to non-profits that serviced only a fraction of the community.

Jerry Brown, San Clemente, noted the benefits in his wife's battle with cancer with the use of medical marijuana and requested the Council to consider permitting of the dispensaries.

Sharon Roberts, (no city provided), requested Council to work with medical marijuana dispensaries to create regulations permitting them.

Terry Shaw, Costa Mesa, announced upcoming Costa Mesa Historical Society events featuring architect Richard Dodd and his presentation titled "The Bungalow Era in Orange County," Professor Denny Haythorn and the history of Whittier College, and Michael Berry "Final Resting Places: Orange County's Dead and Famous" in conjunction with the Historical Society's open house.

Martha Rice, Costa Mesa, expressed her appreciation for having the facilities and options for medical marijuana dispensaries in the city.

Santina Giordano, (no city provided), spoke in support of medical marijuana.

Chris McEvoy, Costa Mesa, reported the Sunset Ridge Park Environmental Impact Report in Newport Beach was available for review and expressed concern on the impact to Costa Mesa, and noted support in the use of medical marijuana.

Tex Williamson, Costa Mesa, spoke in support of medical marijuana and expressed concern for access to medical marijuana for patients with transportation issues.

A video depicting the alternatives considered in the feasibility study for the SR-55 was presented.

Chris McEvoy, Costa Mesa, expressed concern in the reduction in parking standards and increase in density, and suggested that Council reconsider parking issues.

#### VII. PUBLIC HEARING

1. PUBLIC HEARING: AN ORDINANCE OF THE CITY COUNCIL OF COSTA MESA, CALIFORNIA, AMENDING TITLE 11 (OFFENSES - MISCELLANEOUS) OF THE COSTA MESA MUNICIPAL CODE REGARDING GRAFFITI.

Council Member Bever noted the different versions of the report that was distributed, and noted staff's confusion as to the changes made and therefore requested a continuance to provide time for a clarification. The Mayor expressed his preference for staff to proceed with the report and answer Council's questions.

MOTION: continue the public hearing.

Moved by Council Member Eric R. Bever. Motion died for lack of second.

Assistant City Manager Tom Hatch introduced the item. Police Officer Jason Chamness introduced the Tracking and Automated Graffiti Reporting System(TAGR's) program, a reporting system to track taggers countywide, used to deter graffiti and vandalism, and for greater convictions and restitution of the abatement. He along with Mr. Hatch and Police Chief Shawkey responded to Council Members' questions regarding restitution by the responsible party, collaboration with the Newport Mesa Unified School District, multiple offenders, success rate and enforcement, ordinances of other cities, defined and identified graffiti

implements, community service versus fees, a private property owners' responsibility relative to the removal of the graffiti, property liens of the offender and that of the victimized property owner, and adhesive stickers as graffiti implements.

Deputy City Attorney Elena Gerli presented a summary of the draft ordinance amendments, which were suggested to provide more tools to law enforcement to curb graffiti. She covered the proposed regulations, and the penalties. She responded to questions from the Council regarding prosecution, retailer responsibilities, graffiti and the abatement from private property, methods of collecting restitution, parental responsibility, adhesive stickers, cost recovery system, civil versus criminal prosecution, attorney fees, and administrative cost recovery.

Discussion amongst the Council and staff ensued regarding non-responsive property owners for graffiti abatement, the responsibilities of retailers relative to display and sale of "Graffit implements", adhesive stickers, "slap tagging" and its enforcement, merchandise inventory by retailers, the collection of restitution, reimbursement versus fines and penalties, notification of provision to the businesses, parental responsibility provisions, gang graffiti versus taggers, public outreach.

Council Member Bever expressed concern that elements of the proposed ordinance, such as the extensive definition of "graffiti implements", the needing of proper identification for the purchase of a number of the implements, and a retailers merchandise inventory. He felt that parts of the ordinance might be placing a burden on the victim, and the retailers in the process and not fully addressing the graffiti problem.

Council Member Foley, expressed her support of the TAGRS program, supported the proposed ordinance as it provided stricter tools to combat graffiti, as well as some parental accountability. She noted however some concerns with areas of the ordinance regarding adhesive stickers, and the "intent" language as a part of the implement possession by minors.

The Mayor recessed the meeting at 9:00 p.m. The Mayor recovened the meeting at 9:14 p.m.

Mayor Mansoor expressed that he would be more supportive of financial penalties rather than that of community service for offenders.

Martin H. Millard, Costa Mesa, opined that stickers should not be included in the ordinance and expressed concern for gang graffiti.

Colin McCarthy, Costa Mesa, supported the proposed ordinance commenting that it provided the necessary tools for the Police Department to combat graffiti, expressed concern regarding prosecutions by the District Attorney and recommended a revision to the graffiti award program.

Beth Refakes, Costa Mesa, was supportive of the proposed regulations, for holding the parents responsible, and expressed concern for property owners whose properties are continously targeted.

Chris McEvoy, Costa Mesa, suggested that teachers should be offered an incentive/reward for identifying taggers in school, and inquired about driving restrictions for convicted taggers.

#### **VIII OLD BUSINESS**

1. Continued from the meeting of March 2, 2010, request to waive Planning Application fee for Coast Motel for the conversion of a motel property into Single Room Occupancy (SRO) or Family Room Occupancy (FRO) units.

Senior Planner Minoo Ashabi presented the staff report and responded to questions from the City Council regarding the application process, the purpose of the outreach encouraging SRO conversions as part of the goal of Housing Element, and the options provided.

Mayor Mansoor expressed his concern regarding the intended use of the property after the conversion, suggested senior housing, and wondered how the waiving of the fee would facilitate the improvement of the property.

The property owner, Corey Donaldson, responded to questions from the Council regarding the conversion of the motel property to apartments, noting their goal was a desire for a more stable population to reside in the property.

Council Member Foley expressed her confusion at the process and in the

need of the fee waiver for the conversion, yet to be approved.

Council Member Monahan expressed the waiver noting that the project would be in keeping with the goals of the Old Newport Boulevard Specific Plan and the Housing Element.
