AMENDMENT NUMBER ONE TO PROFESSIONAL SERVICES AGREEMENT WITH SOUND MEDIA FUSION, LLC

This Amendment Number One ("Amendment") is made and entered into this 6th day of April, 2021 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and SOUND MEDIA FUSION, LLC, a California limited liability company ("Consultant").

WHEREAS, City and Consultant entered into an agreement on March 1, 2021 for Consultant to provide sound monitoring services (the "Agreement"); and

WHEREAS, City and Consultant desire to amend the Scope of Services as set forth in Exhibit "A," attached hereto and incorporated herein by this reference; and

WHEREAS, City desires to increase Consultant's maximum compensation accordingly to Fifteen Thousand Dollars (\$15,000.00).

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The Scope of Services shall be amended as set forth in Exhibit A.
- 2. Section 2.1 of the Agreement shall be amended to reflect that Consultant's total compensation shall not exceed Fifteen Thousand Dollars (\$15,000.00). Consultant shall be paid according to the fee schedule set forth in Exhibit A.
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 4. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
- 5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.


