

**AMENDMENT NUMBER ONE  
TO PROFESSIONAL SERVICES AGREEMENT  
WITH  
WOOD ENVIRONMENT & INFRASTRUCTURE SOLUTIONS, INC.**

This Amendment Number One ("Amendment") is made and entered into as of the 17th day of May, 2021 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and WOOD ENVIRONMENT & INFRASTRUCTURE SOLUTIONS, INC., a Nevada corporation registered to do business in California ("Consultant").

WHEREAS, City and Consultant entered into an agreement on June 10, 2020 for Consultant to provide industrial and commercial facility inspection services (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the Agreement for four (4) additional one (1) year periods; and

WHEREAS, City and Consultant desire to extend the term for one (1) year, through June 9, 2022.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The term of the Agreement shall be extended through June 9, 2022.
2. Section 2.1 of the Agreement shall be amended to reflect that Consultant's annual compensation shall not exceed Forty-One Thousand Nine Hundred Ninety Dollars (\$41,990.00). Consultant agrees to provide services at the rates set forth in Exhibit C of the Agreement.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
4. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement. Counterpart written signatures may be transmitted by facsimile, email or other electronic means and have the same legal effect as if they were original signatures.
