

**AMENDMENT NUMBER TWO  
TO PROFESSIONAL SERVICES AGREEMENT  
WITH  
ABSOLUTE CONSULTING ENGINEERS INC.**

This Amendment Number Two ("Amendment") is made and entered into as of the 29th day of June, 2021 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and ABSOLUTE CONSULTING ENGINEERS INC., a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on June 30, 2020 for Consultant to provide engineering design services (the "Agreement"); and

WHEREAS, on January 28, 2021, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly; and

WHEREAS, City and Consultant now desire to amend the Scope of Services to include the additional services set forth in Exhibit "A," attached hereto and incorporated herein by this reference; and

WHEREAS, City desires to increase Consultant's maximum compensation accordingly to Forty-Eight Thousand Seven Hundred Twenty-Five Dollars (\$48,725.00); and

WHEREAS, City and Consultant further desire to extend the term of the Agreement for two (2) years, through June 29, 2023; and

WHEREAS, City and Consultant intend and desire that this Amendment be effective retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This Amendment shall be effective retroactive to the Effective Date.
2. The Scope of Services shall be amended to include the additional services set forth in Exhibit A.
3. Section 2.1 of the Agreement shall be amended to reflect that Consultant's total compensation shall not exceed Forty-Eight Thousand Seven Hundred Twenty-Five Dollars (\$48,725.00). Consultant shall be paid in accordance with the fee schedule set forth in Exhibit A, on a progress basis as set forth in the Agreement.
4. The term of the Agreement shall be extended through June 29, 2023.
5. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
6. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.

7. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
