WHEREAS, both Parties agree to extend the term of the Cooperative Agreement through September 30, 2023 at no increase to the maximum obligation;

NOW, THEREFORE, it is mutually understood and agreed by AUTHORITY and CITY that Cooperative Agreement No. C-8-1881 is hereby amended in the following particular only:

Amend ARTICLE 9. ADDITIONAL PROVISIONS, A. TERM OF AGREEMENT, Page 7 of 10, line 10, to delete "September 30, 2020" as the expiration date of the Cooperative Agreement, and in lieu thereof insert "September 30, 2023".
