AMENDMENT NUMBER FIVE TO PROFESSIONAL SERVICES AGREEMENT WITH MICHAEL BAKER INTERNATIONAL, INC.

This Amendment Number Five ("Amendment") is made and entered into this 19th day of October, 2021 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and MICHAEL BAKER INTERNATIONAL, INC., a Pennsylvania corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on March 19, 2019 for Consultant to provide environmental consulting services in connection with the One Metro West project (the "Agreement"); and

WHEREAS, on December 17, 2019, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly; and

WHEREAS, on May 29, 2020, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly, and acknowledged and agreed that funding for Consultant's services is provided by the One Metro West project applicant, Rose Equities LLC; and

WHEREAS, on February 2, 2021, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation accordingly; and

WHEREAS, on February 16, 2021, City and Consultant extended the term of the Agreement for three (3) years, through March 18, 2024; and

WHEREAS, City and Consultant now desire to amend the Scope of Services to include the additional services set forth in Exhibit "A," attached hereto and incorporated herein; and

WHEREAS, City desires to increase Consultant's compensation accordingly to Two Hundred Forty-Nine Thousand Four Hundred Forty-One Dollars (\$249,441.00).

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. The Scope of Services shall be amended to include the additional services set forth in Exhibit A.
- Section 2.1 of the Agreement shall be amended to reflect that Consultant's total compensation shall not exceed Two Hundred Forty-Nine Thousand Four Hundred Forty-One Dollars (\$249,441.00).
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 4. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.

5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
