4. OLD BUSINESS

a. Active Transportation Projects - Staff Update

Jennifer Rosales, Transportation Services Manager, emailed updates for the active transportation projects to Committee members and liaisons prior to the Committee meeting.

b. Pedestrian Master Plan

Ms. Rosales introduced PMP Project team:

Frank Barrera presented draft chapters of PMP, draft recommendations, project update, and next steps. Another public outreach meeting will be scheduled for input into the draft PMP.

Committee members and liaisons provided comments on the draft PMP chapters presented. The discussion included:

- Draft Chapter 5 is under development and will be sent to Committee members for review which will include a draft implementation plan with prioritization and funding strategies.
- The project team will review available public health date to include such as socioeconomic indicators and needs.
- Discussion included high visibility crosswalks adjacent to schools; leading pedestrian intervals (LPI's); and speed reduction where warranted.
- The PMP will provide a toolbox for treatments that are available to use on pedestrian corridors throughout the City where warranted.
- Project team discussed the selection and prioritization process including highest need based on data collected in the report.
- Lighting, street trees, and an overall focus on corridors was discussed.
- Pedestrian and sidewalk connectivity as a focus of the plan
- Table of contents and footers requested for plan clarity.

Comments from members of the public:

 Marc Vukcevich suggested the toolbox be expanded to include graphics and noted lack of sidewalks and connectivity between east and west side.

Member Bridget Gleason commented in favor of a bike lane on Monrovia.

Member Ralph Taboada noted that the Harbor cornerstone bike path lacks a center line and suggested a proposed ad hoc subcommittee for a bike facility on Newport Boulevard to Newport Beach.

Chair Cynthia McDonald commented in favor of reviewing Newport Boulevard and in favor of green paint in bike lane conflict zones along Fairview Road.

Member Jimmy Vivar commented on the recent fatal collision at Victoria and Placentia.
