

**AMENDMENT NUMBER TWO
TO PROFESSIONAL SERVICES AGREEMENT
WITH
OCCU-MED, LTD.**

THIS AMENDMENT NUMBER TWO ("Amendment") is made and entered into this 20th day of December, 2021 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and OCCU-MED, LTD., a Delaware corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement dated November 18, 2020 for Consultant to provide pre-employment medical examinations and evaluation services (the "Agreement"); and

WHEREAS, on July 22, 2021, City and Consultant amended the Agreement to increase Consultant's annual compensation; and

WHEREAS, City and Consultant now desire to amend the Agreement to reflect an additional clinic, Concentra, in Consultant's network and to set forth the fees for utilizing such clinic.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Consultant's Proposal, set forth in Exhibit A of the Agreement, shall be amended to reflect the addition of Concentra in Consultant's network, with services to be provided at the following locations:

2. Exhibit 5 of Consultant's Proposal shall be deleted in its entirety and replaced with the revised Exhibit 5 attached as Exhibit A to this Amendment.
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
4. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.

5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
