AMENDMENT NUMBER TWO TO PROFESSIONAL SERVICES AGREEMENT WITH SIEMENS MOBILITY, INC.

This Amendment Number Two ("Amendment") is made and entered into this 7th day of December, 2021 ("Effective Date"), by and among the CITY OF COSTA MESA, a municipal corporation ("City"), SIEMENS MOBILITY, INC., a Delaware corporation ("Siemens") and YUNEX LLC, a Delaware limited liability company ("Yunex").

WHEREAS, City and Siemens Industry, Inc. entered into an agreement on March 1, 2015 for Siemens Industry, Inc. to provide traffic signal maintenance services (the "Agreement"); and

WHEREAS, on November 27, 2018, City and Siemens amended the Agreement to reflect the assignment of the Agreement from Siemens Industry, Inc. to Siemens; and

WHEREAS, on May 26, 2021, Siemens advised the City that it would be transferring its Intelligent Traffic Systems ("ITS Business") to Yunex on July 1, 2021, and that such transfer would include the transfer of all contracts pertaining to Siemens' ITS Business, including the Agreement, and requested the City's consent to the transfer and assignment of the Agreement; and

WHEREAS, on November 8, 2021, City consented to the assignment of the Agreement; and

WHEREAS, City, Siemens and Yunex desire amend the Agreement to reflect the assignment and Yunex's assumption of Siemens' obligations pursuant to the Agreement and to amend the Agreement as set forth herein.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. Yunex hereby assumes all of Siemens' responsibilities, liabilities, covenants and obligations set forth in the Agreement, and agrees to perform and observe all of Siemens' covenants and obligations contained in the Agreement.
- 2. Any and all references in the Agreement to "Siemens Mobility, Inc." shall be amended to read, "Yunex LLC."
- 3. Section 6.4 of the Agreement shall be amended to set forth Consultant's contact information as follows:

- 6. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
