AMENDMENT NUMBER THREE TO PROFESSIONAL SERVICES AGREEMENT WITH BUCKNAM INFRASTRUCTURE GROUP, INC.

This Amendment Number Three ("Amendment") is made and entered into as of January 5, 2022 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and BUCKNAM INFRASTRUCTURE GROUP, INC., a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on January 6, 2015 for Consultant to provide professional engineering services to update the City's Pavement Management Program (the "Agreement"); and

WHEREAS, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation to One Hundred Sixty-Two Thousand Nine Hundred Eighteen Dollars (\$162,918.00), through Amendment Number One to the Agreement, dated October 16, 2018; and

WHEREAS, Section 4.1 of the Agreement provides for an initial term of six (6) years, ending on January 6, 2021, with the option to extend the term for up to two (2) additional one (1) year periods; and

WHEREAS, City and Consultant extended the term through January 5, 2022, through Amendment Number Two to the Agreement, dated January 6, 2021; and

WHEREAS, City and Consultant desire to extend the term for one (1) additional year, through January 5, 2023; and

WHEREAS, City and Consultant intend and desire that this Amendment be effective retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. This Amendment shall be effective retroactive to the Effective Date.
- 2. The term of the Agreement shall be extended through January 5, 2023.
- 3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
- 4. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
- 5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
