

**AMENDMENT NUMBER TWO
TO PROFESSIONAL SERVICES AGREEMENT
WITH
AGA ENGINEERS, INC.**

THIS AMENDMENT NUMBER TWO ("Amendment") is made and entered into as of April 2, 2022 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and AGA ENGINEERS, a California corporation ("Consultant").

WHEREAS, City and Albert Grover & Associates, Inc. entered into an agreement dated April 3, 2018 for Albert Grover & Associates, Inc. to develop traffic signal infrastructure and timing improvements in connection with the Bear Street Traffic Signal Coordination Project (the "Agreement"); and

WHEREAS, on September 3, 2020, City and Consultant amended the Agreement to reflect Albert Grover & Associates, Inc.'s assignment of the Agreement to Consultant; and

WHEREAS, Section 4.1 of the Agreement provides for a term of four (4) years, through April 2, 2022; and

WHEREAS, City and Consultant desire to extend the term for one (1) year, through April 2, 2023; and

WHEREAS, City and Consultant intend and desire that this Amendment be effective retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This Amendment shall be effective retroactive to the Effective Date.
2. The term of the Agreement shall be extended through April 2, 2023. ✓
3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
4. All other terms, conditions, and provisions of the Agreement shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.


