

**AMENDMENT NUMBER SEVEN
TO PROFESSIONAL SERVICES AGREEMENT
WITH
INTERWEST CONSULTING GROUP INC.**

This Amendment Number Seven ("Amendment") is made and entered into as of the 16th day of July, 2022 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and INTERWEST CONSULTING GROUP INC., a Colorado corporation registered to do business in California ("Consultant").

WHEREAS, City and Consultant entered into an agreement dated July 17, 2018 for Consultant to provide engineering staff support services to the Transportation Services Division (the "Agreement"); and

WHEREAS, Section 4.1 of the Agreement provides for a term of three (3) years, with the option to extend the term of the Agreement for two (2) additional one (1) year periods; and

WHEREAS, City and Consultant amended the Scope of Services and increased Consultant's maximum compensation through Amendment Number One to the Agreement, dated February 15, 2019; and

WHEREAS, City and Consultant further amended the Scope of Services and increased Consultant's maximum compensation through Amendment Number Two to the Agreement, dated June 4, 2019; and

WHEREAS, City and Consultant further amended the Scope of Services and increased Consultant's maximum compensation through Amendment Number Three to the Agreement, dated October 1, 2019; and

WHEREAS, City and Consultant increased Consultant's maximum compensation to enable City to use Consultant for additional services through Amendment Number Four to the Agreement, dated March 3, 2020; and

WHEREAS, City and Consultant increased Consultant's maximum compensation to enable City to use Consultant for additional services through Amendment Number Five to the Agreement, dated February 16, 2021; and

WHEREAS, City and Consultant increased Consultant's maximum compensation to enable City to use Consultant for additional services and extended the term of the Agreement through July 16, 2022 through Amendment Number Six to the Agreement, dated July 16, 2021; and

WHEREAS, City and Consultant now desire to extend the term for one (1) additional year, through July 16, 2023.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The term of the Agreement shall be extended through July 16, 2023.

2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
3. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.


