

**AMENDMENT NUMBER TWO  
TO PROFESSIONAL SERVICES AGREEMENT  
WITH  
NATIONAL DATA AND SURVEYING SERVICES, INC.**

This Amendment Number Two ("Amendment") is made and entered into this 9th day of November, 2022 ("Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City"), and NATIONAL DATA AND SURVEYING SERVICES, INC., a California corporation ("Consultant").

WHEREAS, City and Consultant entered into an agreement on April 29, 2021 for Consultant to provide traffic data collection services on an as-needed basis (the "Agreement"); and

WHEREAS, City and Consultant entered into Amendment Number One on April 14, 2022 to increase Consultant's maximum compensation to an amount not to exceed Fifteen Thousand Dollars (\$15,000) and extend the term of the Agreement to end on April 28, 2024; and


WHEREAS, City desires to increase Consultant's maximum compensation by Ten Thousand Dollars (\$10,000.00).

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Section 2.1 of the Agreement shall be amended to reflect that Consultant's total compensation shall not exceed Twenty-Five Thousand Dollars (\$25,000.00).
2. All terms not defined herein shall have the same meaning and use as set forth in the Agreement.
3. All other terms, conditions, and provisions of the Agreement not in conflict with this Amendment shall remain in full force and effect.
4. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.
