6. COMMITTEE MEMBER COMMENTS

Committee member Shiroma reported on her Finance subcommittee. Felice noted that their subcommittee is looking at a couple of topics; 115 Pension Trust, pension obligation bonds, other post employment benefits, and unfunded pension liability. Finance Director Molina wanted to thank everyone for their congratulations. Director Molina also mentioned that they were able to deposit the 1.5 Million dollars into the 115 Trust.

Director Molina also provided FiPAC with the staffing update letting them know Assistant Finance Director Robert Moya is no longer with the City of Costa Mesa and is leaving the state.

Director Molina also responded to member Taboada's question regarding the Motel 6/ARPA Funds. Director Molina clarified that the City itself is not acquiring the Motel 6 but is helping to fund with the County and some other grants to transition the Motel 6 into some housing for veterans, seniors, some low income individuals etc... This was a one time funding, not ongoing. The 5 million dollars was from the second tranche of the ARPA money received. Lastly Director Molina thanked Chandler for coming in to report to FiPAC and also thanked and Acting Assistant Finance Director Andrea Pham for her report as well.
