Principal Updates

TeWinkle-8th graders took a field trip to visit EHS and attended with parents Future Eagle Night. Both had good turnouts. Over 300 people attended Future Trojan night. A nighttime dance is being planned and the school is asking to reallocate \$3000 to help make this a successful event. B.Thorpe made a motion to reallocate \$3000 for dance expenses and \$500 for student in need entrance fees. M. Graham made a second. All in favor.

Estancia- M. Halt was not in attendance. K. Barloon shared the good news regarding EHS becoming a Distinguished School. M. Graham gave some theater updates.

Treasurer's Report

B. Thorpe presented account balances totaling \$1,087,324 ending February 2024. \$469,655 in Merrill and \$600,389 in Raymond James. \$17,671 in US Bank checking. All distributions to school have been made; \$28,000 to EHS and \$19,000 to TW. Our 2023 allocation has been met.

Old Business

M. Savage, EHS Head Counselor, agreed that Pathways was the best avenue for our \$2000. scholarship donation. The EHS Scholarship Committee will be asked to narrow the applications to two or three from each Pathway and submit to the ETSF Board for final pick.

New Business
