

**AMENDMENT NUMBER FOUR TO
PROFESSIONAL SERVICES AGREEMENT
WITH
THE INTERSECT GROUP LLC**

This Amendment Number Four ("Amendment") is dated the 30th day of January, 2024 ("Amendment Effective Date"), by and between the CITY OF COSTA MESA, a municipal corporation ("City") and THE INTERSECT GROUP, LLC, a Georgia limited liability company ("Consultant") successor-in-interest to VINCENTBENJAMIN GROUP, LLC ("VincentBenjamin Group").

WHEREAS, City and Consultant entered into an agreement on October 9, 2020, for Consultant to provide temporary staffing services for the Finance Department (the "Agreement"); and

WHEREAS, City and Consultants entered into Amendment One on October 1, 2021, to extend the term for one year through October 8, 2022; and

WHEREAS, City and Consultant entered into Amendment Two on October 8, 2022, to extend the term for one additional year through October 8, 2023; and

WHEREAS, City and Consultant entered into Amendment Three on May 2, 2023, to increase the maximum compensation allowed and recognizing Consultant's acquisition of VincentBenjamin Group; and

WHEREAS, Section 4.1 of the Agreement provides for a term of one (1) year, with the option to extend the Agreement for two (2) additional one (1) year periods; and

WHEREAS, City and Consultant desire to extend the term for one (1) year, from October 9, 2023, through October 8, 2024.

WHEREAS, City and Consultant intend and desire that this Amendment be effective retroactive to the Effective Date.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. This Amendment shall be effective retroactive to the Amendment Effective Date.
2. Section 4.1 of the Agreement is revised to provide:

"Term. This Agreement shall commence on the Effective Date and continue for a period of four (4) years through October 8, 2024, unless previously terminated as provided herein or as otherwise agreed to in writing by the

parties. This Agreement may be extended by one (1) additional one (1) year period upon mutual written agreement of both parties .

3. All terms not defined herein shall have the same meaning and use as set forth in the Agreement, as amended.
4. All other terms, conditions, and provisions of the Agreement, as amended, shall remain in full force and effect.
5. This Amendment may be executed in one or more counterparts, each of which shall be deemed an original. All counterparts shall be construed together and shall constitute one agreement.


